You are a Settlement Class Member if you were a person in the United States (i) who, when making payment at a physical Hibbett, Sports Additions or City Gear retail store located in the United States, (ii) made such payment using a credit or debit card (iii) and for whom Hibbett, Sports Additions or City Gear printed a point-of-sale receipt (iv) which displayed more than the last 5 digits of the credit or debit card (v) between December 15, 2020, and February 23, 2022.

To be eligible for payment you must submit a valid claim no later than February 8, 2023.
